<u>Items of Interest</u> (Jacob Roberson)

- Proposition 4 will be on the ballot in November, and this proposition will provide funds for IRWM projects if approved. No IRWM money was included in the State budget and full funding may not be fully restored for 2 or 3 years for many State grant programs, including IRWM. If the bond for Prop 4 passes, it will mean that projects can apply directly to IRWM funding instead of looking for other funding sources.
- The Sierra Vista Scenic Byway will be hosting their annual tour this year on Saturday, August 31st, starting at 9 am. The tour this year will be of the Ross Cabin, with guest speaker Connie Popelish.

The Sierra Vista Scenic Byway is also needing volunteers for their Grizzly Central Gravel and Century Ride on October 5th. This is the main fundraiser for the Scenic Byway. If you are interested in attending, please contact Doug Waltner by emailing dwaltner@netptc.net.

The Urban Streams Restoration Program (USRP), is currently accepting applications. This program was established by Water Code section 7048 which declared that urban creek protection, restoration, and enhancement are best undertaken by local agencies and organizations with assistance from the State. The USRP funds projects and provides technical assistance to restore streams impacted by urban development to a more natural state.

Eligible applicants include nonprofits, public agencies, and Tribal governments. This program does require a partnership of 2 applicants (sponsor and cosponsor): one local public agency, Tribe, or certified 501(c)(3) non-profit organization and local community group. The USRP recognizes partnerships when there is a signed MOU between authorities representing the partners included in the application.
