The first 15 minutes of each regular meeting is set aside for members of the public to comment on any item within the jurisdiction of the Group, but not appearing on the agenda. Items of Interest (Jacob Roberson)

- Back at the beginning of January, Governor Newsom released his proposed FY 2025-26 budget, which includes a breakdown of Prop 4's \$10 billion in funding, which is authorized for water, wildfire and land protection measures passed in November 2024. The budget dedicates approximately \$2.65 billion to be appropriated in FY 2025-26, \$6.5 billion proposed for "out-years", and roughly \$800 million to the Legislature's discretion.

Please note that funding is uncertain at this time as this is a proposed breakdown. Due to the devastating wildfires in Los Angeles, significant changes to this funding may take place before the budget is finalized in June.

- Late last month, Governor Newsom signed Executive Order N-16-25, which set forth the conditions under which water users may divert and store excess water from incoming winter storms.

The Executive Order suspends the local flood plan requirement of Water Code 1242.1, which codified many elements of the previous 2023 Flood Executive Orders and allows for diversions of flood flows for recharge without water rights. The State Water Resources Control Board has updated its [1242.1 Technical Guidance](#) that provides additional details of the existing 1242.1 requirements and addresses today's Executive Order.
